# Spring Meeting May 19th

It would be excellent information to include in a New Property Owners Welcome Packet. Waldo and Jim will collaborate on this.

- 1. Phil moved that the SCLF pay for an ad in the Winter Gazette to thank all County Board members who voted for the Shoreland / Wetlands amendments. The ad would cost about \$79.00. Motion waas seconded and Carried
- 2. There is discussion at the county level about whether there should be habitable spaces above garages.
- 3. Phil has suggested that the county formulate zoning to regulate mines of all kinds not just nonmetallic mines for gravel. There may soon be applications for sand mines in our county.
- 4. The Treland request. for 51 R. V. sites on Moss Creek. Existing camp grounds in the county are trailer parks with permanent placements. If the Treland R.V park were to be transient only, then all trailers would have to be on wheels and could not become permanent.

### Namekagan River Association - Bill

He attended the January 29th meeting at the Sawmill Saloon. Many conservation exhibitors were there. It was announced that the Sigurd Olson family was donating land to Northland College for education outreach purposes. Scott Peterson of the Namekagon River Association said that the association is making progress.
